7 **A BILL FOR AN ACT** to amend the *National Environmental Protection Act 1984* (35  
8 MIRC Ch. 1) to specify the coordination of water use and sanitation in order to  
9 implement the National Water and Sanitation Policy and Action Plan adopted by the  
10 Cabinet in 2014.

11 **BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

12 **§1. Short Title**

13 This Act may be cited as the National Environmental Protection  
14 (Amendment) Act 2016.

15 **§2. Amendment**

16 To include a new section as follows:

17 **§127A. Integrated Water Resources Management and Water**  
18 **Sanitation**

19 (1) The Authority shall, in consultation with the Office of the  
20 Chief Secretary, coordinate the monitoring and  
21 implementation of the National Water and Sanitation Policy  
22 and its Action Plan by the following:

- 23 (a) reviewing, recommending and enacting procedures for  
24 the monitoring and implementation of the Policy;
- (b) reviewing and, where necessary, preparing legislation,  
regulations and policies relevant to the water and

1 sanitation sectors and the declaration and protection of  
2 natural water resources;

- 3 (c) establishing performance monitoring systems for water  
4 and sanitation providers for annual reviews;
- 5 (d) establishing performance monitoring systems for water  
6 and sanitation providers for annual reviews;
- 7 (e) reporting to the Cabinet on water resources in the  
8 Republic, including water and sanitation outlook;
- 9 (f) preparing an integrated strategic plan for the water and  
10 sanitation sectors for annual review;
- 11 (c) conducting water and sanitation sector assessments for  
12 donor reviews;
- 13 (h) facilitating periodic water and sanitation sectors  
14 program alignment;
- 15 (i) establishing and managing a water and sanitation  
16 database;
- 17 (j) developing and implementing public communications  
18 and awareness programs on water and sanitation  
19 issues, including National Water Day activities;
- 20 (k) overseeing licensing and use of groundwater resources.

- 21
- 22 (2) All references to “water use policy” or any variation thereof in  
23 the *Planning and Zoning Act 1987* (10 MIRC Ch. 2) shall be  
24 repealed.

25 **§3. Effective Date**

26 This Act shall take effect in accordance with the Constitution and the Rules  
27 of Procedures for the Nitijela.

3 BILL SUMMARY

4 In March of 2014, the Cabinet endorsed the National Water and Sanitation Policy  
5 and the 5-year National Water and Sanitation Policy Action Plan. The Policy entails  
6 that a National Commission be established to oversee and coordinate integrated  
7 water resource management in the Republic. The protection of groundwater and  
8 other water resources of the Republic is critically important to providing an essential  
9 fresh water supply for the growing population demands of the nation. This is  
10 especially true in the face of climate change. The Policy covers the areas of water  
11 quality, water quantity, water and sanitation management, drought and extreme  
12 weather (climate change) and highlight the need to improve access for the  
13 disadvantaged.  
14

15 However, rather than creating a National Commission to manage water use and  
16 sanitation, it was determined that the *National Environmental Protection Act 1984* be  
17 amended to specify with such responsibilities. This Bill adds on the duties of  
18 monitoring and implementing the National Water and Sanitation Policy and the 5-  
19 year National Water and Sanitation Policy Action Plan to the EPA Authority.
