5 A BILL FOR AN ACT to give the authority to the Local Government Councils the
6 jurisdiction to enact local ordinance prescribing different curfew hours for Juveniles
7 as necessary.

8 BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

9 §101. Short Title.

10 This Act may be cited as the *Juvenile Procedure (Amendment) Act 2018*.

11 §102. Amendment.

12 Section 312 of the Juvenile Procedure Act shall be amended to read as
13 follows:

14 §312. Curfew Hours for Juveniles.

15 (1) No person under eighteen (18) years of age shall be allowed on the
16 streets or at any facility or public places in Majuro Atoll or Ebeye
17 between the hours of 10:00 p.m. in the evening and 6:00 a.m. in the
18 morning from Monday through Sunday.

20 §312A. Local jurisdiction

21 Nothing in Section 312 shall prevent any Local Government from enacting
22 Ordinance that would otherwise prescribe different curfew hours in their
23 own local jurisdiction in accordance with its circumstances.

§103. Effective date.

This Act shall take effect on the date of certification in accordance with the Constitution and the Rules of Procedures for the Nitijela.
